2. If any student absents himself/herself for more than 7 days continuously without any prior written application. He/ she will not be allowed to appear in the class tests and will not be given any test paper. He/she may be deemed to be expelled from the Institute. No separate intimation will be sent to the parents. No fee or part of the fee paid/ encashed will be refunded in such cases. The decision of the managing Director in this regard will be final and binding on the students and parents.
3. It is for the student himself/herself to see whether he/ she is eligible for a particular examination or not. The Institute does not hold itself responsible if a student's admission form cannot be forwarded or is rejected by the examining body on or

any ground whatsoever. Such a student cannot claim a refund of the whole or any part of the fee he/she has paid to the Institute.

4. A student who is late for classes/tests. Will not be allowed to enter the classroom.
5. Any study material given during the classes or otherwise, shall not be given to those students which are absent without prior applications from the parents. No request / Personal appointments in this regard shall be entertained.
6. Each student will be issued an identity card. The entry into the classes/Institute will be only with an Identity Card. If the identity card of a student is lost/misplaced, a duplicate I-card can be asked from the institute against payment of 50/- if any students found missing the I-card he/she will be rusticated from the institute.
